COMPLAINT

The Complainant, being duly sworn, makes Complaint to the above-named Court and states that there is probable cause to believe that the defendant committed the following offense(s). The Complainant states that the following facts establish PROBABLE CAUSE:

Complainant, Rick Denmark, is a Detective with the Prior Lake Police Department. Among Complainant's duties are the enforcement of the laws of Minnesota and the investigation of criminal activity in Scott County, Minnesota. During the course of Complainant's investigation, Complainant has had occasion to confer with witnesses and/or other officers and/or to observe evidence.

On November 13, 2008, at approximately 10:08 p.m., Prior Lake Police Officers responded to a reported assault that occurred in the Tiowakan Church parking lot, Prior Lake, Scott County, Minnesota. Dallas James Grimes and Gary Dale Grimes both reported that Rolando Demetrio Ruiz, D.O.B. 11/09/1990, hereinafter referred to as the Defendant, racked a round and pointed a gun at them.

Specifically, Mr. Dallas Grimes and Mr. Dale Grimes reported that after dinner, they were driving by the Tiowakan Church when they saw car lights on in the church parking lot. Mr. Dallas Grimes thought that the car belonged to Defendant and he wanted to speak with Defendant about money that Defendant took from him. Mr. Dallas Grimes drove into the parking lot and pulled in front of Defendant's car blocking Defendant, and his passenger, K.J.B., in their parking space. The Grimes reported that both Defendant and Dallas Grimes got out of their cars. Defendant then walked towards the Grimes' car with a gun in his hand. Defendant racked a round and pointed the gun at both men and told them he was going to kill them. Pursuant to his father's command, Mr. Dallas Grimes got back into the car.

Defendant also got back into his car and drove out of the parking lot. The Grimes' followed as Defendant dropped K.J.B. at her home. They continued to follow him until they saw the police were in pursuit of Defendant's car. Police officers apprehended Defendant in the CVS parking lot near the intersection of County Road 83 and Dean Lakes Boulevard. As they approached his vehicle, he threw a gun out of his car. The Grimes identified both the car and the handgun. Defendant told officers that he did not understand what was going on and that "I was always told that if I found something that wasn't mine I needed to get rid of it."

K.J.B. told officers that she and Defendant were at the church parking lot when the
