The Grand Jurors of the State of Florida, duly called, impaneled and sworn to inquire and true presentment make in and for the body of the County of Miami-Dade, upon their oaths, present that from in or between September 2004 and September 2005, within the County of Miami-Dade, State of Florida, MICHELLE SPENCE-JONES did knowingly, unlawfully and feloniously obtain or use or did endeavor to obtain or use funds, valued at twenty thousand dollars (\$20,000.00) or more but less than one hundred thousand dollars (\$100,000.00), the property of Miami-Dade County, as owner or custodian, with the intent to temporarily or permanently deprive Miami-Dade County of a right to the property or of a benefit therefrom or to appropriate the property to said defendant's own use or to the use of a person not entitled thereto, in violation of s. 812.014(2)(b) Florida Statutes, to the evil example of all others in like cases offending and against the peace and dignity of the State of Florida.
